### **Child Protection**

It is an offence for a prohibited person to apply for, attempt to obtain, undertake or remain in child-related employment, or to sign this declaration. A prohibited person is a person who is convicted of the following (whether in NSW or elsewhere):

- murder of a child
- serious sex offence, including carnal knowledge
- child-related personal violence offence (an offence committed by an adult involving intentionally wounding or causing grievous bodily harm to a child)
- indecency offences punishable by imprisonment of 12 months or more
- kidnapping (unless the offender is or has been the child's parent or carer)
- offences connected with child prostitution
- possession, distribution or publication of child pornography; or
- attempt, conspiracy or incitement to commit the above offences.

A prohibited person includes a Registrable person under the Child Protection (Offenders Registration) Act 2000.

Details of these offences can be found online at Working With Children Employer Guidelines. A conviction includes a finding that the charge for an offence is proven, or that a person is guilty of an offence, even though the court does not proceed to a conviction.

### **Other Terms and Conditions**

The applicant:

- agrees to waive rights against the organisation including directors and volunteers.
- agrees to consent to necessary medical treatment and agree to pay for any medical treatment costs (including transport by ambulance).
- acknowledges that the sport has some limited group personal accident and liability insurance policies in place and that the details of cover can be viewed on the ANSW website [www.nswathletics.org.au](http://www.nswathletics.org.au).
- acknowledges that the individual should consider their own financial circumstances and consider taking out private health insurance and income protection. The applicant acknowledges that if a claim is made he or she is responsible for paying the excess.
- acknowledges that a cancellation of a registration by either party will not result in a refund except where deemed appropriate by ANSW in accordance with the ANSW constitution and any other relevant policies.
